A LETTER FROM OUR EXECUTIVE DIRECTOR & CHAIR

Jonathan McGillivray (Chair of the Board) and Sarah Van Exan (Executive Director)

WITH EACH PASSING YEAR, THE NEED TO BUILD ENVIRONMENTAL LEADERSHIP IN CANADIAN POLITICS MULTIPLIES ALONGSIDE THE IMPACTS OF CLIMATE CHANGE.

That's a line we've used before in communications to our supporters, but it merits some reflection. The impacts of climate change are unfolding in Canada and around the globe at an alarming pace. At GreenPAC, 2023 was the first year the Director of our Parliamentary Internship for the Environment program had to issue regular extreme weather warnings to our interns, advising them to work from home as Ottawa faced unsafe air quality levels from wildfire smoke (experienced across much of Canada) and multiple tornado alerts.

Millions more Canadians felt the direct impacts of climate change in 2023. That should translate into higher expectations of our elected representatives to demonstrate leadership and accelerate durable policy solutions that support climate stability.

On the other hand, however, a variety of factors distract, disaffect, and limit both Canadians and our political leaders. The affordability crisis is stretching pocketbooks. Trust in our politicians and political institutions is in decline. Growing polarization and ideological politics reduce cross-party collaboration and, as a result, lead to fewer policy solutions that will withstand elections. It is no surprise that this fails to inspire children and youth, many of whom already feel real mental and social health impacts of maturing in a pandemic and **are experiencing climate anxiety and distress at concerning rates**.

This challenge reinforces the critical importance of our work at GreenPAC. The runway for climate change solutions is short. We need to do everything we can to make sure our political systems and processes, and the leaders within them, work with the greatest possible ambition toward equitable, sustainable change.

This fiscal year, we were proud to continue and grow that effort by expanding the Parliamentary Internship Environment to **10 exceptional youth leaders** who added essential environmental capacity on the Hill and developed the skills needed to be transformative changemakers. We brought together **hundreds of advocates, experts, and political leaders across parties** for dialogue and educational programming on environmental politics. We convened online and inperson workshops with youth from across the country as part of our third annual FLIP Summit to explore their vision of environmental leadership, inspire meaningful engagement in politics and elevate their competencies as environmental changemakers. We formed a **national Youth Advisory Council** that is bringing vital perspectives and fresh ideas to our work. And, once again, we checked in with GreenPAC's endorsees to find out how they've been using their time to champion the environment and remind them that Canadians expect leadership.

NEW DIRECTIONS

The past year for GreenPAC has been marked by some major undertakings that have been quietly taking shape behind the scenes.

GreenPAC played an instrumental role in founding Environmental Leadership Canada (ELC), a new Canadian charity committed to building a fresh wave of environmental leaders and boosting the capacity of everyday Canadians who care about the environment to engage in our democracy and hold elected officials accountable. In Fall 2023, ELC took the reins on GreenPAC's educational, capacity-building initiatives, like the Parliamentary Internship for the Environment (PIE), 100 Debates on the Environment, Every Day Advocates, and our FLIP events (for Future Leaders in Politics). GreenPAC remains a critical partner in these initiatives.

We'd like to take a moment to recognize our team – this was a huge undertaking for every staff member over and above their regular responsibilities and programming commitments. We have also been busy readying a new program for launch — the **Municipal Climate Internship (MCI)**, delivered in partnership with ELC. MCI will boost the capacity of rural municipalities to take climate action and invest in the development of young community climate leaders by placing them in the offices of local municipalities where they will gain first-hand experience and knowledge in municipal climate issues, solutions, and local decision-making processes. It is the only Canadian municipal internship program with a climate focus and among the only political internship programs for youth.

In its pilot year (beginning in January 2024), MCI will place three interns in three host municipalities in southeastern Ontario. We plan to be operating in at least three provinces or territories by Year 3.

We look ahead to FY24 with enthusiasm, optimism, and gratitude to everyone who engaged in our work this year — our donors, sponsors, volunteers, program participants, the Parliamentarians who hosted our interns, our growing intern alumni network, and followers. Thank you for helping us make the environment a driving force in Canadian politics. Your support and our accomplishments are inseparable.

The third annual FLIP Summit, hosted through PIE, was deconstructed into three creative sessions throughout the spring of 2023. This year's summit theme aimed to shift the narrative around youth involvement in politics. Workshops, panel discussions, keynote presentations, and collaborative visioning exercises, including our first in-person FLIP workshop, examined topics like the role of youth councils, effective advocacy letter writing, and personal branding and storytelling. All provided rich opportunities for learning, networking, and leadership development. These sessions, attended by 60-100 registrants each, facilitated engagement with young leaders nationwide, encouraging their active participation in environmental politics and producing a joint Youth Statement on Environmental Leadership in Politics.

As in past years, FLIP was delivered with extensive collaboration. This year's partners included Ecology Ottawa, Environtastic (University of Ottawa), Youth Climate Lab, the Canadian Council for Youth Prosperity, and Sustainable Youth Canada.

Thanks to our PIE funders (see pg. 11) for making FLIP possible. A special thanks to **The Emerald Foundation** for supporting FLIP's goals and other GreenPAC work this year to engage youth and uplift their voices in environmental politics. Through practical, skill-building, and JEDI-led content, participants deepened their understanding of environmental and political systems. Youth leaders in Ottawa learned about the importance of communicating a political message with personal stories to reach across the divide and speak to climate anxieties. Youth speakers like Skw'akw'as Dunstan-Moore discussed their experiences within youth advisory councils, including tokenization in some decision-making spaces, a toocommon reality echoed through session participants' feedback. In our Letters for Leadership workshop, guest speakers and Youth Climate Lab's letter-writing techniques empowered and catalyzed youth to advocate effectively for their perspectives and the kind of environmental leadership they expect.

Year 5 brought notable successes, including welcoming the largest and most diverse cohort yet, and partnering with 12 Parliamentarians to place 10 exceptional young leaders. 90% of interns identified with one or more equity-seeking groups. This year, PIE also formally introduced a specialized program stream for Indigenous Interns and continued the Sustainable Agriculture stream that was piloted with immense success in Year 4, as well as a themed placement in Climate Finance, a growing area of interest.

PIE interns also had the unique opportunity to participate in the program's very first interjurisdictional learning trip to Queen's Park in Toronto. During the visit, interns engaged in meaningful discussions with MPPs and explored the legislative environment through guided tours. This initiative further enriched their understanding of the broader political landscape, fostering a holistic learning experience beyond the federal level.

The program's influence extended through collaborations with Senators for Climate Solutions and the All-Party Climate Caucus, showcasing interns' impactful contributions in various areas. While the confidential nature of aspects of their work limits



detailed accounts, examples include research for amendments addressing urban-rural divides in agriculture, staffing a Minister at an international forum, writing a supporting passage for a motion on electoral reform, and organizing events, roundtables and workshops on environmental and intersecting topics.

Year 5 was also marked by dynamic challenges. Confronting multifaceted hurdles demanded adaptive and innovative strategies to ensure seamless program continuity. Extreme weather events and natural disasters in Ottawa, particularly tornado warnings and poor air quality, prompted adjustments and, at times, a reduction in outdoor activities and coordinating hybrid working models. Simultaneously, divisive movements that took place in Ottawa introduced additional security considerations. Managing the most diverse cohort yet presented the unique challenge of varying equity literacy levels, requiring a thoughtful and inclusive approach. An unexpected MP portfolio shuffle led to the swift realignment of interns to new offices. Despite these challenges, the PIE program demonstrated resilience and innovation, with strategies adjusted to uphold high engagement and learning standards, underscoring the program's unwavering commitment to providing interns with a robust and meaningful experience. Over 10 months, interns participated in 70+ learning sessions, including fireside chats with sectoral experts, conference and summit attendance, training, workshops, and skillbuilding activities.

EVERY DAY ADVOCATES

This year we continued to deliver educational events aimed to build the knowledge and capacity of grassroots advocates to interact with our political leaders and systems, like the aforementioned panel that dug into the opportunities and realities of using Private Members' Bills as tools for change. This year we also put a lot of work into new and improved resources and tools that aim to demystify political processes that impact the pace of environmental change. Our new Toolkits like Budget Basics 101, Parliamentary Dynamics & Structures, and our Intro to Lobbying shed light for advocates on how our political system works and how to navigate its realities to advance environmental progress.

We also made big strides to make our reservoir of knowledge on hosting all-candidates' debates in the leadup to elections more accessible and engaging with our new 16-part video series for organizers. These videos offer quick takes on some of the most critical step-by-step knowledge we've gathered in supporting community organizers across Canada (together with partners like Équiterre) to hold almost 200 debates and townhalls as part of our 100 Debates on the Environment work. These resources are now available in a new <u>easy-access resource library</u>, hosted by our educational partner, Environmental Leadership Canada, with more resources and videos to follow.

CHECKING IN

Last year, we checked in with the MPs we endorsed in the 2021 federal election to learn how they are leading for the environment in office, and spotlighted some of their important work in our annual report.

This year, we did it again, asking endorsees about how they have continued to champion the environment this past year in Parliament, in their riding, and behind the scenes.

Their responses gave us cause for optimism – these environmental leaders are working across party lines, seeking innovative solutions, and driving public engagement in tackling some of the most pressing challenges of our time.

The highlights that follow represent only a sample of our endorsees and a snippet of their efforts.

These spotlights do not reflect GreenPAC's support of any particular laws, policies, petitions or motions (proposed or adopted); as a nonpartisan organization, we do not take policy stances. Instead, we support, celebrate and amplify environmental leadership in all forms across the political spectrum.

2023 SPOTLIGHTS

MP DAN ALBAS

Central Okanagan-Similkameen-Nicola, Conservative

Though no longer Shadow Minister for the Environment and Climate Change, MP Dan Albas has continued to champion environmental leadership in the 44th Parliament and meet with environmental stakeholders. On the House floor, he has drawn attention to issues of illegal dumping in Crown forests, greywater dumping, and exposure to mercury pollution in northern communities, and in Committee, pushed for sound policies on forest management, wildfire mitigation and flood risk mapping. For his constituents, he has been a vocal advocate for ensuring the equity of government policies on electric vehicles, carbon pricing, and single-use plastics. Behind the scenes, MP Albas has helped to expand the membership of the All-Party Climate Caucus that facilitates bipartisan environmental dialogue.



THE HONOURABLE KARINA GOULD

Burlington, Liberal

In her role as Minister of Families, Children and Social Development, the Hon. Karina Gould led on delivering Canada's 2nd Voluntary National Review to the UN High Level Political Forum for Sustainable Development, which facilitates knowledge sharing and robust climate policymaking internationally. As MP for Burlington, she has actively championed investments to protect green areas in and around her riding, including an ecological corridor pilot project for the Cootes to Escarpment EcoPark system. Behind the scenes, MP Gould worked collaboratively with local officials to secure nearly \$400,000 in federal funding for new zero-emissions buses in Burlington; this initiative strategically leveraged partnerships with other municipalities to bring down purchasing costs and accelerate the transition to zero-emissions public transportation.



THE HONOURABLE STEVEN GUILBEAULT



Laurier-Sainte-Marie, Liberal

In his role as Minister of Environment and Climate Change, the Hon. Steven Guilbeault has been a key force in launching Canada's first national comprehensive framework for climate change adaptation and securing billions of dollars in investments for floodresilient infrastructure and emissions reductions. His leadership made Canada the first G20 country to phase out inefficient fossil fuel subsidies, and helped to broker the ambitious Kunming-Montreal Global Biodiversity Framework at COP15, signed by almost 200 countries. An advocate for tackling environmental racism, he worked to ensure Indigenous leadership in conservation was a major theme of COP15, and more recently, helped facilitate First Nations co-leadership on a working group with the Alberta Government to address tailings leakages in the province.

MP LORI IDLOUT

Nunavut, NDP

As Parliament's only representative of Nunavut, MP Lori Idlout brings firsthand knowledge of the catastrophic effects of the climate crisis to her work in Ottawa. In March 2023, she introduced a Private Members Bill to ensure that the legal duty of free, prior and informed consent of Inuit and Indigenous peoples is sought at the acquisition stage of new mining projects, rather than after exploratory rights are issued and significant investments made. In her words, this bill would provide a "pathway for immediate action" to advance Canada's UNDRIP obligations. MP Idlout has also used her time on the House floor to push for policies that reduce Nunavut's reliance on diesel, support the transition to renewables, and reflect and respect the deep knowledge, skills and experiences of Indigenous communities.



MP HEATHER MCPHERSON



Edmonton-Strathcona, NDP

MP Heather McPherson (re-)introduced bills to require federal environmental impact assessments for all new coal mines, and to increase the investigative powers of the Canadian Ombudsman for Responsible Enterprise into environmental abuses abroad. Both currently await second reading in the House of Commons. In late 2023, she represented her party in committee sessions to aggressively push for transparency from provincial regulators and industry on the problem of toxic seepage from Alberta tailings ponds. She continues to work with Indigenous communities, scientists, and environmental organizations to end her province's reliance on fossil fuels, halt the release of contaminated water from tailings ponds, and ensure the protection of Wood Buffalo National Park/Peace Athabasca Delta, including by seeking federal funding for Indigenous environmental monitoring projects.

MP MIKE MORRICE

Kitchener Centre, Green

MP Mike Morrice increased public engagement in environmental politics by sponsoring climate-related petitions in the House of Commons, maintaining a "climate crisis playlist" on YouTube of his interventions on the House floor, and amplifying his work in the media. He was instrumental in getting a government minister to publicly commit during Question Period to using "all tools available" to protect Ontario's Greenbelt. An advocate for proportional representation to, among other things, ensure more durable and robust climate policymaking, MP Morrice worked across party lines to spearhead, and jointly second, a Private Members Motion on electoral reform, which drew support from NDP, Liberal and Conservative colleagues. His priorities for the coming year include a push to end fossil fuel advertising and to create a windfall tax for oil and gas companies.



Note: The significant decrease in GreenPAC's cash position and deferred revenue at FY23 year-end compared to FY22 is attributable to the start-up of the Centre for Environmental Leadership in Canada (which operates under the name Environmental Leadership Canada or ELC). Grants awarded prior to the start of the new program year (Sep 1, 2023 to Aug 31, 2024) were awarded directly to Environmental Leadership Canada (with the support of GreenPAC). This year, GreenPAC also transferred \$35K in deferred grant revenue and made a \$10K donation to ELC from accumulated savings (i.e. cash that the Board, with the support of program funders, previously earmarked for a Parliamentary Intern emergency fund). Along with other FY23 expenses (e.g. legal services), over 50% of this year's loss is attributable to one-time expenses related to supporting the successful start-up of ELC.
